A. Governor Sundquist's Budget Proposal

Increase of \$691 million for the current budget

\$179 million Increase in K-12 Education

- \$179 million increase in K-12 public schools
- Knox County will receive \$115 million total state dollars. Blount County \$40 million. Sevier County \$28 million.

\$136 million Increase in Higher Education

- Stops tuition hikes at the University of Tennessee, Pellissippi State and Walters State Community College
- Continues programs such as Agriculture Extension and Adult Education
- Raises salaries to stop faculty erosion

\$114 million Increase to TennCare

- Covers 1.43 million people who otherwise would be served by Medicaid and those who are uninsured or uninsurable
- Assists local governments in paying for indigent health care

\$163 million Increase in State Government

- Funds State Parks
- Improves public health and increases funding for public safety including the Highway Patrol
- Develops areas such as Homeland Security

B. D.O.G.'s Budget Proposal

Cuts \$775 million from the current budget

\$397 million Cut from K-12 Education

- Adds 5 students to every public school classroom
- Lays-off 14% of the state's 66,000 teachers
- Affects sports, arts, music and special education

\$71 million Cut from Higher Education

- Increases tuition by 15% at the University of Tennessee, Pellissippi State and Walters State Community College to compensate for loss in funding
- UT Board of Trustees and Board of Regents must cover \$71 million in loss of funding

Abolish TennCare

Saves \$50 million but leaves 350,000 uninsured and uninsurable people to rely on local governments for health care

\$110 million Cut from State Government

■ Abolishes Dept.of Tourism

Comments

- Abolishes Dept.of Economic and Community Development
- Cuts \$28 million in Law Enforcement, Highway Patrol, Prisons and Veterans Programs
- Cuts \$12 million in State Parks and Soil Conservation
- Cuts \$12 million from Transportation, including Welcome Centers and Rest Areas

A. 4.5 % Flat Income Tax Proposal

This plan would produce approximately \$1.1 billion

- Exemptions on the first \$15,000 for single, the first \$30,000 for married filing jointly and \$1,500 deduction per dependent
- Repeal all current income taxes on savings, bonds and investments
- Remove sales tax on grocery food, clothing and non-prescription drugs
- Constitutional Amendment limits state spending to 6% annual growth

B. 9.75% Sales Tax Proposal

This plan would produce approximately \$1.1 billion

- State sales tax would be increased to 9.75%
- Current maximum rate is 8.75%
